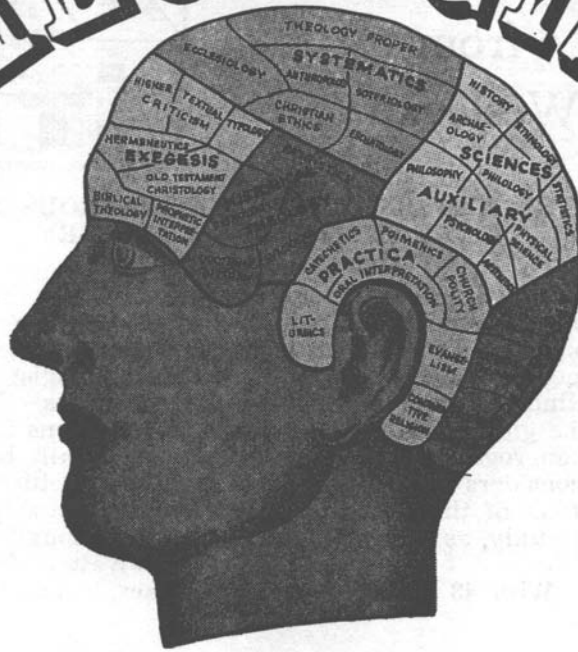

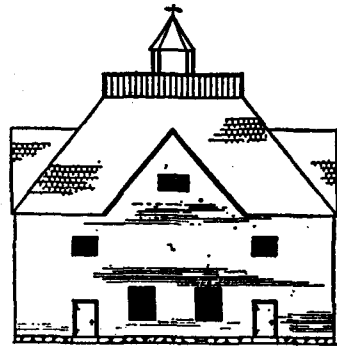

CONGREGATIONAL COMMONWEALTH
Connecticut, 1636-1662

By Mary Jeanne Anderson Jones

From their establishment in the 1630's to the promulgation of the royal charter in 1662, Connecticut settlements were unique among the English colonies. Their institutions of church and state were their own, and they existed independently under their own constitution, the Fundamental Orders.

This study of the Congregational commonwealth covers the polity of that quarter-century with admirable comprehensiveness, thorough scholarship, and a fullness of detail far surpassing that of any previous work. It treats the actual founding of the colony and the backgrounds in England and Massachusetts; the churches, their claims, and the degree of their control; the Fundamental Orders themselves; the courts and the law; and the movement toward a royal charter.

The focus ultimately is on the Fundamental Orders, their nature as an expression of the Puritan environment, and the governmental system they established.

The Great Church in Captivity

STEVEN RUNCIMAN

A history of the Patriarchate of Constantinople from the eve of the Turkish conquest to the Greek War of Independence.

The first part describes the organization of the church before 1453 and its relations with the Empire and with the Roman and other churches. The second part—1453 to 1821—tells of the church's subservience to the Turkish Sultans before it attained its ultimate position as the focus of Greek nationalism. New material is presented on relations between the Greek church and the Anglican, Calvinist and Lutheran churches during the sixteenth and seventeenth centuries.

Elizabeth and the English Reformation

WILLIAM P. HAUGAARD

Professor Haugaard reassesses and reconstructs the early years of Elizabeth's rule when men argued, schemed and fought to bend the national church to conform to their own particular vision of an ideal Christianity.

The focal point of the study is the Convocation of 1563 at which all major issues of the period were discussed, resulting in decisions that propelled the Church of England along the route chosen by the queen and her bishops.

Dr Costeloe describes the organization and activities of the *Juzgado* and discusses its place in Church-State relations.
