PREMIS data dictionary

The Preservation Metadata: Implementation Strategies Working Group (PREMIS) has published *Data dictionary for preservation metadata: Final report of the PREMIS working group*, which contains a description of the PREMIS data model, the data dictionary (version 1.0), examples, a description of the methodology, implementation considerations, special topics, and a glossary. As noted in the introduction, the data dictionary "defines and describes an implementable set of core preservation metadata with broad applicability to digital preservation repositories . . . not intended to be fixed and final . . ."
