A) Prefix — it is added to the beginning of a word, such as write - rewrite.

B) Suffix - it is an additional morpheme to the end of a word, hope - hopeless.

3. Compounding. In this process, new words are created with the combination of two or more existing words with a different meaning. For example, sun + flower = sunflower

Black + board = Blackboard

These words can be written as a single, hyphenatedly and separately such as, foot + ball , well-known , ice cream

4. Conversion. This term involves the process of shifting a word into another category without changing its form.

For example: Run - she is running very fast.(verb)

He went for a quick run. ( Noun)
