As of 2020, there were approximately 500 formally qualified Chinese language teachers in the Philippines, with a majority concentrated in economically advanced cities, such as Manila, Cebu, and Davao. In contrast, remote and economically disadvantaged areas exhibit extremely low coverage rates of Chinese language teachers, and in some instances, the presence of such teachers is nonexistent. This uneven distribution has exacerbated the disparity in Chinese language education between urban and rural areas in the Philippines.

Three primary factors contribute to the scarcity of Chinese language teachers. Firstly, the Philippines lacks a comprehensive system for training Chinese language educators. Currently, only a limited number of colleges and universities offer coursework pertinent to Chinese language education, which primarily focuses on language proficiency training and lacks specialized research and practical applications related to Chinese language teaching methodologies. Secondly, the profession of Chinese language teaching lacks attractiveness. Subpar salary levels and ambiguous career progression pathways have prompted numerous potential educators with robust language abilities to pursue higher-income industries. Furthermore, societal misunderstandings concerning Chinese language education, coupled with fluctuating demand for Chinese language learning among certain schools and students, have led to a weakened sense of professional identity among Chinese language teachers. Lastly, political dynamics in China-Philippines relations also exert a specific influence on the stability of Chinese language teaching personnel. For instance, certain schools in the Philippines depend on volunteer teachers dispatched by China, but the brevity of their service tenure hinders the formation of a sustained and effective teaching contingent.

2.3. Analysis of the Source and Applicability of Textbooks

Textbooks are important tools for language education, and their quality and adaptability directly affect learning outcomes. At present, the textbooks for Chinese language education in the Philippines mainly come from mainland China and Taiwan. These textbooks are usually troubled by the problem of insufficient localization and are out of touch with the learning needs of Filipino students.

First, the content design of textbooks lacks localization. Textbooks in mainland China and Taiwan are mostly aimed at spreading Chinese culture, and contain a lot of content about Chinese history, geography and traditional culture. However, these contents are often difficult to resonate with Filipino students. For example, when introducing Chinese festivals such as "Spring Festival" and "Dragon Boat Festival" in textbooks, there is a lack of connection with the local culture of the Philippines, and students' interest and participation are low. In addition, the context settings of these textbooks are mostly based on the social environment of mainland China or Taiwan, which is quite different from the daily life scenes of

Filipino students, and cannot effectively improve students' language application ability.

Secondly, the language difficulty of the textbooks fails to match the starting point of Filipino students' learning. Filipino students usually speak Chinese as their third or fourth language, and textbooks from mainland China and Taiwan usually assume that learners already have a certain level of Chinese character literacy or basic language knowledge. For example, some primary textbooks introduce complex Chinese characters too early and ignore the need to teach pinyin or basic grammar, which is a significant obstacle for beginners in the Philippines.

Finally, the development of localized textbooks in the Philippines faces dual limitations of funding and professional resources. Although some schools and institutions have begun to try to compile textbooks that meet the needs of Filipino students, the lack of national policy support and professional teams has limited the scope of use of these textbooks. In addition, the quality and coverage of localized textbooks cannot be compared with mature textbooks from mainland China and Taiwan, which to some extent limits their promotion and use.

In general, Chinese education in the Philippines presents a situation where multiple opportunities and challenges coexist in terms of social background, teaching staff and textbook adaptability. Despite the growing demand for Chinese education, its development is still constrained by problems such as teacher shortage, textbook disconnection and insufficient policy support. To achieve the sustainable development of Chinese education, more targeted measures must be taken in terms of teacher training, textbook localization and policy implementation.

3. Development Strategies for Chinese Language Education in the Philippines

Schools can collaborate with local Chinese communities to organize cultural events such as Chinese festival celebrations, speech contests, and drama performances. These activities can facilitate students' connection of language learning with real-life scenarios and deepen their understanding of Chinese culture. Additionally, Chinese companies within the community can offer students more practical opportunities and enhance the applicability of language learning by providing internships or language service projects.

3.2. International Cooperation and Resource Sharing

International cooperation has offered a pivotal development platform for Chinese language education in the Philippines, particularly in teacher training, teaching material development, and educational resource allocation.

Strengthening joint teacher training and teaching material development between China and the Philippines is a crucial measure to address the core challenges of Chinese language education. Regarding textbooks, the Philippines can collaborate with publishing houses in mainland China and Taiwan to jointly develop localized textbooks that not only cater to the language learning characteristics of Filipino students but also align with the social and cultural backdrop of the Philippines, reflecting the fusion of bilateral cultures.

The "Belt and Road" initiative has ushered in new prospects for Sino-Philippine educational cooperation. The Philippines can leverage this platform to secure more financial support and educational resources. Through the "Confucius Institute" project, Philippine educational institutions can obtain additional teaching equipment, teacher resources, and scholarship support. Simultaneously, the "Belt and Road" framework provides Filipino students with opportunities to study in China, exposing them to a richer language learning environment and further enhancing the appeal of Chinese language learning. Furthermore, the Philippines can collaborate with other Southeast Asian countries, such as Singapore and Malaysia, to host regional language education forums, share educational resources and

successful experiences, and propel the development of Chinese language education in the region.

3.3. Technological Innovation and Digital Transformation
