• **Applying the New Copyright Law, A Guide for Educators and Librarians** by Jerome K. The guide also includes a careful treatment of interlibrary loans and reproduction of out-of-print and archival materials. • The RTSD Collection Development Committee has recently released **Guidelines for Collection Development**, edited by David Perkins (ALA, 1979, \$5). This small volume prints several ALA committee statements: guidelines for formulation of collection development policies; evaluation of the effectiveness of library collections; review of library collections; and allocation of library materials budgets. Appendixes include a breakdown of the LC classification for use in the national shellist count and descriptions of, and citations to, selected formulas for book fund allocation.

• **The Development of the Chinese Collection in the Library of Congress**, by Shu Chao Hu (Westview Press, 1979, \$20), presents a history of that collection from its beginning in 1869 to 1977. This new volume was issued by the publisher as a Westview Replica Edition, whereby author-supplied camera-ready copy is immediately put into production without further editorial work.

• Eugene Garfield's **Citation Indexing—Its Theory and Application in Science, Technology, and Humanities** (Wiley, 1979, \$15.95) presents Garfield's own personal summary of citation indexing.

• Alice Harrison Bahr is the author of the second edition of **Automated Library Circulation Systems**, covering the 1979-80 period and updating the information from the 1977 edition (Knowledge Industry Publications, 1979, \$24.50).

• **Fantasy Literature: A Core Collection and Reference Guide** (Bowker, 1979, \$14.95) not only presents a bibliography of 240 titles for a core collection but also features a separate section on "research aids," including a bibliography on fantasy scholarship, periodicals, fantasy societies and organizations, literary awards, and fantasy collections in U.S. and Canadian libraries. Marshall B. Tynn, Kenneth J. Zahorski, and Robert H. Boyer are authors of this new reference work.

• The American Association for State and Local History has issued a new volume in its **Bibliography of Historical Organization Practice**. Volume 4, **Documentation of Collections**, compiled by Rosemary Reese (1979, \$12.50), presents sources of information on historical artifacts, decorative arts, antiques, fine arts, folk arts, and crafts.

• Volume 11 of the **Proceedings of the International Association of Technological University Libraries** (IATUL) is devoted entirely to library buildings and presents descriptions of new academic libraries in Britain, Denmark, Sweden, and West Germany. Available from IATUL, Chalmers University of Technology Library, Göteborg, Sweden.

• The University of Pittsburgh study by Allen Kent and his associates entitled **Use of Library Materials**, recently published by Marcel Dekker and reviewed in the November 1979 *C&RL*, has elicited a response from the Senate Library Committee at Pitt: **Report on the Study of Library Use at Pitt by Professor Allen Kent, et al.** The report criticizes the study for a variety of reasons and concludes that it presents "a clear threat and a present danger." It urges that "university administrators and librarians not be influenced by the unfounded criticisms and unwarranted recommendations expressed so forcibly by Professor Kent and his associates." The report is to be made available through the ERIC system.

• The first six volumes in the Melbourne University Press **Australian Dictionary of Biography** cover biographies for 1788-1850 (V.1-2) and 1851-1890 (V.3-6). The newly published volume 7 opens the third period, 1891-1939, with entries A-Ch. (Price: \$37.50.) The dictionary is to be complete in twelve volumes. It is distributed in North and South America by ISBS, Inc., P.O. Box 555, Forest Grove, OR 97116.

• David M. Brownstone and Gorton Carruth's **Where to Find Business Information** (Wiley,

1979, \$34.95) is designed "to show precisely and quickly where current business information is located and how to find it," listing more than 5,000 English-language publications. A "Source Finder" section of 2,500 subject entries directs the reader to full bibliographic citations in the "Sources of Business Information" section.

- *Great Writers of the English Language* (3v., St. Martin's Press, 1979, \$45 each volume) provides biographies, bibliographies, and critical essays on 500 poets (V.1), 500 novelists (V.2), and 200 dramatists (V.3).

- Robert Goehlert's *Congress and Law-Making: Researching the Legislative Process*

(American Bibliographical/Center-Clio Press, 1979, \$17.50) "is designed to help users trace congressional legislation and to familiarize them with the major sources of information about Congress."

- William S. Hein & Co., Buffalo, New York, has published in 144 volumes *The Internal Revenue Acts of the United States, 1909-1950: Legislative Histories, Laws and Administrative Documents*, edited by Bernard D. Reams, Jr. A separate *Guide and Index* is designed "to assist the researcher in identifying and retrieving the relevant documents that make up the legislative histories." The price for the collection is \$5,975. ■■
