PROFILES

RALPH E. MCCOY has accepted an appointment as interim executive director of the Association of Research Libraries for the period January 7–June 30, 1980. He will succeed John G. Lorenz, who will retire as executive director of ARL at the end of 1979.

McCoy, a native of St. Louis, is a graduate of Illinois Wesleyan University and the University of Illinois. He was librarian and assistant professor of industrial relations at the Institute of Labor and Industrial Relations from 1949 to 1955. In 1955 he became director of libraries at Southern Illinois University and served in that position until 1971, when he became dean of library affairs. McCoy retired from Southern Illinois University in 1976. From July 1978 to July 1979 he was interim director at the University of Georgia Libraries.

He is a past president of the Association of College and Research Libraries.

ROBERT MALOY of New York City has been appointed director of Smithsonian Institution Libraries following a two-year search to fill the position, vacant since Russell Shank became director of libraries at the University of California at Los Angeles.

Maloy, who began work August 27, oversees the operations of the central library, including the Dibner Library and the rare book collection, ten bureau libraries, and six major branch libraries. He also works in close cooperation with the independent libraries of the institution's four art bureaus. Smithsonian library facilities are located in Washington, Maryland, Virginia, New York, Massachusetts, and Panama.

Maloy goes to Washington from Union Theological Seminary, where he served as director of the library and professor of history for four

years. During his tenure, the seminary library was automated, its buildings were renovated, and its collections were expanded. Maloy went to the seminary from the School of Theology and the Claremont Graduate School at Claremont, California, where he served for three years.

A native of Cleveland, Maloy completed undergraduate work at the University of Dayton in 1956 and received a master's degree from the Graduate Library School of the University of Chicago in 1961. He earned his doctorate from the University of Freiburg, Switzerland, in 1966 and continued postdoctoral studies at several European universities.

Maloy is a specialist in Western medieval manuscripts, with a particular interest in the conservation problems that confront research libraries.

T. JOHN METZ has been named college librarian and adjunct associate professor of library science at Carleton College in Northfield, Minnesota. Metz has been director of the Midwest Region Library Network (MIDLNET) since 1975. Before that he served for nine years as director of the library at the University of Wisconsin-Green Bay, where he planned and supervised construction of the UW-Green Bay library building and personally purchased the first 60,000 volumes.

A graduate of Heidelberg College, Ohio, Metz earned the M.A. in music at Miami University in Ohio and the master's in library science at the University of Michigan-Ann Arbor, where he was a library science scholar and fellow. An accomplished violinist, he has performed regularly with the Green Bay Symphony since 1967.

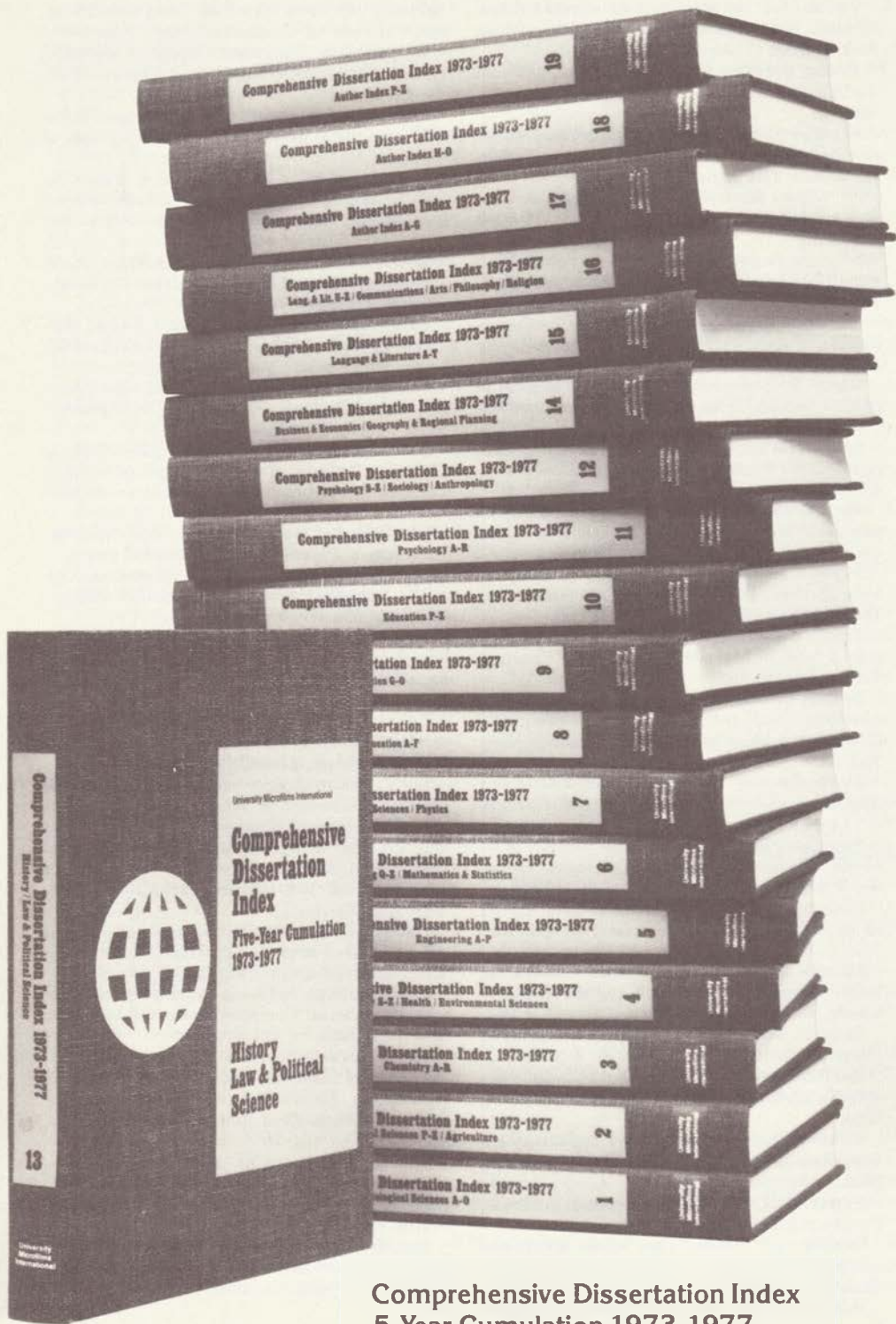

MARIE E. ANGELOTTI, until recently the assistant director for library services at Florida Atlantic University, died October 17 in Boca Raton, Florida.

FORD CURTIS, professor emeritus of English at the University of Pittsburgh, died on September 24. In 1960 Curtis and his wife donated to the University Libraries the Ford and Harriet Curtis Theatre Collection, composed of books, pro-

grams, and memorabilia collected over many years of avid theatergoing. Curtis served as curator from 1961 to 1975, during which time he undertook an expansion of the collection by donations from numerous theatrical sources.

BARBARA ELAINE NICHOLSON, assistant director of libraries at Miami University, Oxford, Ohio, and president-elect of the Academic Library Association of Ohio, died on August 31 in Hamilton, Ohio. She had served as physics-astronomy librarian at the University of Texas at Austin, 1968-70; head science librarian at Miami University, 1970-72; and assistant director of libraries at Miami University, 1972-79. • Aaron and Elaine Cohen's *Designing and Space Planning for Libraries: A Behavioral Guide* (Bowker, 1979, \$24.95) presents the authors' views (one an architect, the other a behaviorist) on how to set up a library and give equal recognition to human behavior as well as to aesthetics and building function. In addition to discussions on planning and layout of library space, the authors also include information on choice of furniture and equipment; lighting, power, and energy; color and signage; and acoustics.

• Frances Simonsen Bernhardt's *Introduction to Library Technical Services* (H. W. Wilson, 1979, \$15) has been prepared "as a textbook for a course in technical services in a two-year library/media technology program" and is designed not only for such students but also for those working in a library as well as those contemplating a career decision.

• Charles L. Bernier and A. Neil Yerkey's *Cogent Communication: Overcoming Reading Overload* (Greenwood, 1979, \$19.95), presenting two aspects of the problem—the unreadable abundance of relevant material and the inability to use what has been read, gives the authors' discussion of methods used to cope with the problem and introduces the principle of cogency (the intelligent and productive use of what is read). This volume is number 26 in Greenwood's Contributions in Librarianship and Information Science.

• The International Federation of Film Archives Cataloging Commission has recently issued *Film Cataloging*, designed as a practical and up-

to-date guide to the theory and practice of film cataloging. Published by Burt Franklin, 1979. Price: \$17.95

• The University Press of Virginia has brought together in the volume *Selected Studies in Bibliography* (1979, \$15) eleven of the articles by G. Thomas Tanselle, published from 1967 through 1979 and treating the theory and tools of bibliography, problems dealing with bindings and papers in descriptive bibliography, and textual criticism and editing.

• The proceedings of the twenty-fourth Allerton Park Institute, 1978, *Supervision of Employees in Libraries*, edited by Rolland E. Stevens, has been issued by the University of Illinois Graduate School of Library Science. Price: \$9.

• Volume 9 of *Advances in Librarianship*, edited by Michael H. Harris (Academic Pr., 1979, \$21), includes six papers: David K. Berninghausen on intellectual freedom; Thomas J. Waldhart and Trudi Bellardo on user fees in publicly funded libraries; Charles W. Evans on paraprofessional library employees; Rosemary and Paul Du Mont on measuring library effectiveness; Abraham Bookstein and Karl Kocher on operations research; and George W. Whitbeck, Jean Major, and Herbert S. White on funding support for library research.

• A new reference work on government documents is Frederic O'Hara's *Guide to Publications of the Executive Branch* (Pierian Pr., 1979, \$29.50 cloth, \$15.00 paper), which has separate chapters treating each of the departments.

• Pierian Press continues its Library Research Guide series with its third volume, James R. Kennedy's *Library Research Guide to Education: Illustrated Search Strategies and Sources*. Price: \$8.50 cloth, \$4.50 paper. ■■
