

bership Committee. The report included recommendations for an ACRL poster, a membership campaign brochure, a renewal letter, a mailing to prospective members, and a new member meeting at Annual Conference.

### Second ACRL National Conference

Virgil F. Massman, chair of the steering committee that is planning ACRL's Second National Conference, informed the board that the conference would take place September 30–October 3, 1981, in Minneapolis, and that the committee was thinking of a format of contributed papers similar to the one used at the Boston conference.

### Sections

The Anthropology Section recommended that ACRL create a council of representatives of

"types of activity" sections. This council would nominate persons for election at large to one of the seats on the ACRL Board of Directors. The board gave its preliminary approval to the Anthropology Section's proposal and will consider it again at the Midwinter Meeting.

### Standards

The board endorsed the recommendation of the Standards and Accreditation Committee that "An Evaluative Checklist for Reviewing a College Library Program" be adopted as a supplement to "Standards for College Libraries."

### Western European Language Specialists Section

The board approved the request of the Western European Language Specialists Discussion Group for section status. ■■

## ACRL Officers for 1979/80

**Le Moyne W. Anderson**, director of libraries at Colorado State University (William E. Morgan Library, Fort Collins, CO 80523), is the forty-first president of the Association of College and Research Libraries. During his term of office, he will preside over the ACRL Board of Directors and the ACRL Executive Committee. He will chair the ACRL Conference Program Planning Committee for the 1980 ALA Annual Conference in New York and will develop the plans for ACRL's major program meeting at that conference.

As president of the division, Anderson will represent ACRL on other ALA committees, including the ALA New York Conference Program Committee and the ALA Divisional Interests Special Committee. He will also represent ACRL and ALA in their relations with other organizations, such as the American Council on Education.

Anderson has been a member of the ACRL Board of Directors, chair of the University Libraries Section, and a member of several ACRL and ALA committees.

**Millicent D. Abell**, university librarian at the University of California, San Diego (Central University Library, La Jolla, CA 92093), has been

elected vice-president/president-elect of the Association of College and Research Libraries. The June 1979 election results for ACRL officers showed 1,527 votes for Abell and 909 votes for Susan Bryntesson, assistant director for technical services, University Libraries, Indiana University, Bloomington.

As vice-president/president-elect of ACRL, Abell will serve on the ACRL Board of Directors and the ACRL Executive Committee. She will chair the ACRL Planning Committee and the ACRL Conference Program Planning Committee for the 1981 Annual Conference in San Francisco. She will represent ACRL on the ALA Appointments Committee, the ALA Planning and Budget Assembly, and the ALA Conference Program Committee for the 1981 conference. At the close of the 1980 Annual Conference, she will become ACRL's forty-second president.

Abell has served ACRL as a member of the Board of Directors, as chair of the University Libraries Section, as chair of the Planning Committee for the 1975 Preconference Institute, and as a member of the committees on Academic Status, Budget, and Bibliographic Instruction.
