22-23—New York: Donald Marchand, dean of the Syracuse University School of Information Studies will be the end-note speaker at a two-day conference for academic and special librarians at the Hotel Syracuse, Syracuse, New York. Marchand will cap off the conference with a talk on the future of the library profession and how students are selected and educated for new and changing roles in the profession. The theme of the conference is "Harmony in a Time of Change: Finding Common Ground," it will focus on issues facing academic and special librarians in the coming decade.
