ACQUISITIONS

• **RADCLIFFE COLLEGE**, Cambridge, Massachusetts, has been presented with *Ms. Magazine's* ten-year collection of "Letters to the Editor." The letters, recognized as a documentary history of women's consciousness in the 1970s, were deposited at the Schlesinger Library by *Ms.* editors Patricia Carbine and Gloria Steinem. Since its inception in 1972 the magazine has received an overwhelming reader response. The Preview issue alone resulted in over 20,000 letters from women all over the country describing their life experience. Although nearly 100,000 letters are being donated to the library (and more will be deposited on a continuing basis), the majority will not yet be available to researchers. To protect the identity of the writers, ten years must elapse from the time of writing before they are made public.

• The **UNIVERSITY OF MANITOBA** Libraries, Winnipeg, have been given the complete research archive of the former *Winnipeg Tribune* by its owner, Lord Thomson of Fleet. The *Tribune* ceased publication in summer, 1980, after ninety years. The collection contains ten tons of newspaper clippings indexed and in chronological order; about one million photographs identified and dated; 10,000 books; and miscellaneous equipment.

• The **UNIVERSITY OF MISSOURI-COLUMBIA** Library has received a collection of 246 Limited Editions Club titles and 92 other volumes from J.W. Kerr of Wilmette, Illinois. Each copy in the collection is in very fine or mint condition, and is

autographed by either the author or by the illustrator or editor. The Limited Editions Club titles were limited to a press run of 1,500-2,000.

GRANTS

• The **UNIVERSITY OF MANITOBA** Libraries, Winnipeg, have received a grant of \$30,000 from the Canadian Social Sciences and Humanities Research Council to purchase materials in the field of Arctic and Sub-Arctic cultural anthropology. The award was granted under the council's Strengthening of Specialized Collections Program and will be used to acquire out of print materials and to augment and complement the present collection.

NEWS NOTE

• The **UNIVERSITY OF KANSAS**, Lawrence, held a dedication ceremony on November 18 for its new Business and Economics Reading Room in Summerfield Hall. The dedication honored emeritus professor of economics Richard S. Howey for his service in building the business and economics collections which have gained international recognition. Howey has been library representative for the Department of Economics since 1930. During that time he has amassed one of the largest collections of economics books in the world, a portion of which is now known as the Howey Collection. His new book, a *Bibliography of General Histories of Economics 1692-1975* will be published by the Regents Press of Kansas in April. ■■

DONALD J. SAGER, who was most recently Commissioner of the Chicago Public Library, has been appointed Visiting Distinguished Scholar for 1982 by Online Computer Library Center (OCLC). Sager intends to conduct research into the economics and administration of public libraries to find ways that OCLC and public libraries can work together more effectively. During the past 17 years of his career, Sager has gained a wide range of administrative experience from director of the Public Library of Columbus and Franklin County (Ohio), 1975-1978, to his current position of president-elect of the Public Library Association. He has also been extremely active in professional and civic associations. He re-

ceived bachelor's and MLS degrees from the University of Wisconsin.

HERBERT S. WHITE, Dean of the School of Library and Information Science, Indiana University at Bloomington, became the 17th Award of Merit winner of the American Society for Information Science (ASIS), presented during the 1981 Annual Meeting in Washington, D.C. on October 28, 1981.

JOSEPH A. McDONALD has been appointed director of the Long Island University Brooklyn Center Library, succeeding Elliott Gatner who retired in February, 1981.

McDonald received his MLS at Drexel Univer-

sity in 1966 and is currently completing his Ph.D. in management and information systems design and evaluation at the same institution. Since 1978 he has been assistant director of libraries for access services at the State University of New York at Albany. Prior to that he has held a number of other administrative positions, including director of library services at Triton College, River Grove, Illinois (1975-77), and head librarian at the Northampton County Area Community College, Bethlehem, Pennsylvania.

McDonald has co-authored a monograph with Donald H. Hunt on *Public Library Architecture* (Drexel Press, 1967), and has had several articles published in *RQ*, *Library Journal*, and the *Drexel Library Quarterly*.

1962 to 1966, when he was appointed at Illinois State.

Kraus has written numerous articles in library journals and a monograph on *William Beer and the New Orleans Libraries 1891-1927* in 1952. He was chair of the executive board of the Illinois Library Association in 1975-76 and is currently finishing a term as editor of ACRL's *Publications in Librarianship* series.

ROSE-GRACE FAUCHER retired as head of the Undergraduate Library at the University of Michigan after 42 years of library service.

DEATHS

W. CARL JACKSON, former dean of university libraries at Indiana University, is presumed dead after having been lost at sea off the coast of Spain in May 1981. Having sailed his yacht, the "Carla Mia," to Ireland in 1978, he was attempting to recross the Atlantic.

Jackson received his MLS in 1952 from Florida

State University. He held positions of increasing responsibility in the libraries of the University of Tennessee, Iowa State University, the University of Iowa, the University of Minnesota, and the University of Colorado before becoming director of libraries at Pennsylvania State University in 1966. On January 1, 1973, he became dean of university libraries at Indiana University, a position he relinquished on June 30, 1980, to allow more time for writing, research, and teaching.

Jackson made significant contributions to the library profession during his career. He was a leader in the founding of MARLIN and MIDLNET, and he led the national effort to develop the Cataloging-in-Publication program now operated by the Library of Congress. He served the American Library Association in several capacities—as chair of many committees, as president of the Resources and Technical Services Division, and as a member of ALA Council.

MARY RUTH MAGRUDER BRADY, dean of Kansas State University Libraries, Manhattan, died November 10. ■■

How did federal programs of interest to college and research libraries fare in the first year of the Reagan Administration? It depends on how one views this most extraordinary legislative session. For the most part, Congress provided more than the Administration requested, but less than the previous year, as shown below for selected programs:
