External Quality Assurance (EQA) is one of many processes used to ensure the analytical quality of laboratory measurements therefore Uganda Martyrs Hospital Laboratory Lubaga has undertaken this measure to guarantee quality results. In an EQA scheme, analysis of identical specimens at many laboratories is done, and results are submitted by individual participants. Results are assessed and compared either against a target value assigned by the organizing or reference laboratory or more often assessed against the consensus value ("trimmed mean value") derived from all results submitted by participants for a particular analyte. As laboratory science advances toward global health, it's crucial that the laboratory enrolls in an EQA scheme for the harmonization of laboratory medicine approach globally, analytical proactiveness, and a requirement for accreditation. Laboratories that don't participate in EQA don't get a chance of assessing the integrity of their entire sample process and neither are accredited hence no regional or international recognition.




Figure 1: This has revealed a positive correlation between EQA performance and the degree of Quality Management Systems for this laboratory.
